Floyd County Board of Education Policy states that only the Board of Education may enter into a contract. Prestonsburg Elementary School's 5th Grade is studying the democratic principles of both state and federal government. This will be an excellent opportunity for our students to see the legislative session in action and gain a personal knowledge of the process. There will no financial issues for the district. All expenses will be paid through student fundraising.

Powers and Duties of the Board of Education 01.11. Many years ago, hospitals were responsible for blood supplies. The common practice for collecting blood for transfusions was to collect donations from patients' family and friends or even from the hospital's own staff. In some cases, family members were required to recruit donors before their loved ones could have surgery. In 1968, a group of concerned Lexington doctors decided blood should be collected, tested and distributed from a central location to give every hospital an equal chance to get needed blood without worrying if there would be enough to go around. With the help of volunteer blood donors, Kentucky Blood Center (KBC) provides blood products to nearly 70 Kentucky hospitals and clinics in more than 60 Kentucky counties.

These dates correspond with BSCTC fall break. Therefore, the FCECA students will miss no college classes and all other participating GT students will miss only Monday and Tuesday. The GT

coordinator, GT instructor, FCECA guidance counselor and school administrators will chaperone the tour. Therefore, there will be no cost for substitute teachers during the tour.

707 KAR 1:320 Individual Education Program (Statutory Authority); KRS 156.070, 156.060, 157.220, and 167.015. Each Admissions and Release Committee (ARC) shall ensure that the length of the instructional/school day for each child or youth with a disability is the same as for children without disabilities except as specified in an Individual Education Plan (IEP). An ARC may determine that the length of the school day can be changed for a child or youth if the medical condition (provided by the physician) of a child or youth indicates that the instructional needs to be altered based upon written evidence. The local education agency shall submit requests for shortened school day to the local board of education for approval prior to notification to the Kentucky Department of Education. Board action shall be subject to confidentiality requirements. An Admission and Release Committee at South Floyd High School have addressed

recommendation involving a shortened school day/week for a student enrolled at this school.
