The agreement is to expand the program to several schools. The goal of the program is to expand services into all Floyd County Schools as determined by the success of the program. No budgetary cost to the district. Student insurance will be billed where applicable. The Floyd County School System agrees to provide space, phone service and access to bathroom facilities.

OSHA regulations. Hepatitis B vaccines are to be offered to any employee whose job duties would put them at risk to exposure to blood and other body fluids or post exposure. The flu vaccine is offered to employees who request this service. Approximately fifteen thousand (\$15,000.00) dollars.

KRS 161.148. Beginning July 1, 2012, the state will charge schools \$10.00 for every criminal record requested. Volunteers are required to have a criminal background check. The Administrative Office of the Courts (AOC) has been covering the cost for nearly 20 years but, due to a budget reduction of \$16.2 million, will now be passing part of the cost on to the schools and school districts. The \$10 fee is discounted from the \$20 for other customers of AOC. Districts have the option of either paying the fee or passing it on to the volunteer to pay.

The estimated cost to the district will be \$10,000. During the 2011-2012 school year, the district had 773 volunteers but the number has been as high as 1,000 in prior years.
