Interest rates have dropped since the first of the year and our fiscal agent has been monitoring one of our bond issues for the possibility of refinancing. Based on interest rates they received last week on our 2005 issue it has been determined that this bond issue now meets the minimum requirements of KDE to refinance. The fiscal agent is not projecting a savings of \$173,597 over the remaining 13 years of the issues for an annual average savings of \$13,353. The current rate on the bond is 4.5% and it is believed to refinance issue would be 2.2%.

707 KAR 1:320 Individual Education Program (Statutory Authority: KRS 156.070, 156.060, 157.220, and 167.015. Each Admissions and Release Committee (ARC) shall ensure that the length of the instructional/school day for each child or youth with a disability is the same as for children without disabilities except as specified in an Individual Education Plan (IEP). An ARC may determine that the length of the school day can be changed for a child or youth if the medical condition (provided by the physician) of the child or youth indicates that the instructional needs to be altered based upon written evidence. The local education agency shall submit requests for shortened school day to the local Board of Education for approval prior to notification to the Kentucky Department of Education. Board action shall be subject to confidentiality requirements. An Admission and Release Committee at Prestonsburg High School, Allen Elementary School, and Adams Middle School have all respectively addressed recommendations involving a shortened school day/week for students at their school.

Ms. Meade made the motion and Dr. Varia seconded the motion to approve first reading for Floyd County Board of Education policy 09.2212 Students – Physical Restraint and Seclusion and Procedures 09.2212 AP.12 and 09.14 AP.232.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

KRS 162.90 Powers and Duties of the local board. First reading for Floyd County Board of Education Policy 09.2212 Students –Physical Restraints and Seclusion and Procedures 09.2212 AP.12 and 09.14 Ap.232. Due to regulatory deadlines and other processing issues, KSBA has completely redesigned and renamed this policy to address the release of student records information to representatives of an authorized state child welfare agency. The current form that it replaces is not needed because parents are notified in the annual FERPA notice which provides student record information be sent when a student transfers to a school, school system or institution of postsecondary education where the student enrolls or seeks to enroll. Although this form is not required by law, KSBA recommends the Board accept it since a new federal law authorizes such release to child welfare agencies in order to facilitate continuity of services for children placed under the protection of welfare agencies.

ORDER NO. 17737

Hal Bowman, Inc (Item 6-K)

Ms. Meade made the motion and Dr. Varia seconded the motion to approve contract for Prestonsburg Elementary, Adams Middle School, and Prestonsburg High School with Hal Bowman, Inc. (Teach Like A Rock Star) for Professional Development on July 31, 2013.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

Board Policy states that only the Board of Education may enter into contracts. Approval of contract for Prestonsburg Elementary School, Adams Middle School, and Prestonsburg High School (Floyd County Schools) with Hal Bowman, Inc. (Teach Like a Rock Star) for Professional Development on July 31, 2013. These three schools are seeking to improve instruction

and student engagement. In the past several schools have sent representatives to various trainings surrounding the “Teach Like A Rock Star” event. This is an opportunity for all three staffs to be trained at a reasonably priced event that will not require travel and other expenses.

ACT WorkKeys (Item 6-L)

Ms. Meade made the motion and Dr. Varia seconded the motion to approve contract for ACT WorkKeys Services for Betsy Layne High School.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

All contracts must be signed by the Superintendent and/or Board of Education. Betsy Layne High School is requiring utilizing ACT WorkKeys as an opportunity to test student’s onsite for College and Career Readiness. College and Career Readiness is a component of the accountability system and students are more comfortable and perform better on test when administered in their own environment.

Ms. Meade made the motion and Dr. Varia seconded the motion to approve BG-4 final pay application/direct purchase orders for Duff Elementary gym roof project.

Capital Construction Process 702 KAR 4:160. Consider approval of BG-4’s for General Construction Direct Purchase Orders and Certification for

payment of the Re-Roof Project at James A Duff Elementary. Total cost for construction is \$104,103.00 and Direct Purchase Orders is \$44,485.00.

Ms. Meade made the motion and Dr. Varia seconded the motion to approve advertising for sealed bids for auto parts, eye exams, physicals, medical waste, and board depository.

KRS 156.265; 275; BOE Policy 4.9, BOE Policy 01.1, 04.32; KRS 45A.345-460. Authorize advertising for sealed bids for the following items; auto parts, eye exams, physicals, medical waste, and board depository. The district bids out various items on a bi-annual basis with the items listed above, with the items being set for the even numbered years. The contracts will be for one year with the renewal for one additional year.

Financial Auditing Firm (Item 6-O)

Ms. Meade made the motion and Dr. Varia seconded the motion to approve one year extension of contract with current financial auditing firm, Walled, Puckett and Anderson, PSC for FY 2013 Financial Audit Services.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

KRS 156.265; 275; BOE Policy 4.9. Mandated and budgeted expenditure. The annual financial audit is mandated per statute and board policy. The firm who has done the past 7 years is Walled, Puckett & Anderson, PSC CPA's and the price for last year's audit was \$19,985. The district did advertise for bids last year and only two firm's submitted proposals. Our bid specifications permit one year renewals.

TC-4 Application Process (Item 6-P)

Ms. Meade made the motion and Dr. Varia seconded the motion to approve Board Order for Emergency Certified Substitute Teachers as part of the TC-4 application process.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

16 KAR 2.030 Emergency Certification. All emergency certified substitute applications (TC-4) are now administered through the on-line certification system of the Certification office of the Educational Professional Standards Board. The Board order is necessary for processing of these applications as part of this inter-active process requires district staff to input data related to Board approval to seek these specific certificates.

ORDER NO. 17743

PGES (Item 6-Q)

Ms. Meade made the motion and Dr. Varia seconded the motion to declare that Floyd County Schools shall adopt the Professional Growth and Evaluation System (PGES) provided by Kentucky Department of Education.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

KRS 162.90 Powers and duties of the local board. All schools shall participate in the newly developed PGES evaluation program for the 2013-2014 school year. PGES was developed by the Kentucky Department of Education as an evaluation and support system that goes beyond NCLB's minimum Highly Qualified Teacher (HQT) standards, provides more meaningful information about the effectiveness of teachers and principals, and can be used to inform professional development and improve practice. This system, informed by research that affirms that educators have significant and lasting effects on student learning, draws on multiple measures of instructional and leadership practices to measure and support teacher and principal effectiveness. Kentucky has received an ESEA waiver

that requires the state develop, adopt,, plot, implement, and sustain a fair and rigorous evaluation and support system for teachers and leaders. The Floyd County local evaluation committee asks that the Floyd County Board of Education adopt the basic PGES procedure as the state recommends. Approximately \$15,000 for principal testing to be taken from Race to the Top funds already acquired.

ORDER NO. 17744

Bidding Insurance Coverage (Item 6-R)

Ms. Meade made the motion and Dr. Varia seconded the motion to utilize Kentucky Educational Development Cooperative (KEDC) Program for bidding Fleet, General Liability and Educators Legal Liability Insurance coverage for the 2014 Fiscal year.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

BOE Policy 03.125, 01.11, 05.6; KRS 45A.345-460. The fiscal impact will not be known until bids are received. The district has budgeted for these items as past year rates. The district is required to bid out property and fleet insurance per KRS 45A.345 and 45A.365 while liability need not be bid per KRS 45A.380(10). However, most districts see better pricing when all lines of insurance are bid together. KEDC has a formalized process for sending out request for proposals and detailed bid specifications that should benefit the district.

Ms. Meade made the motion and Dr. Varia seconded the motion to approve the 2013-2014 School Calendar.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

FRYSC Positions (Item 6-T)

Ms. Meade made the motion and Dr. Varia seconded the motion to approve changes in days/hours and/or abolishment of FRYSC positions for the 2013-2014 School Year.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

Board Policy 03.221, 03.2332, and 03.271. reductions will enable Family Resource/Youth Service Centers stay within their projected budgets for 2013-2014. Advisory council minutes for all changes are:

Betsy Layne Elementary FRYSC – to reduce project assistant position from 200 days to 180 days/year. Hours would remain at 7 hours/day.

Mud Creek Community FRYSC – abolish the assistant position.

Prestonsburg High School YSC – reduce assistant position from 6 hours/day to 4 hours/day. Days would remain at 185.

Allen Elementary FRYSC – reduce assistant position from 7.5 hours/day to 6.5 hours/day. Days would remain at 220.

Trip will be paid by fundraising. If enough money isn't raised, parents/guardians will be responsible for paying. The Family Resource Center will assist those that don't raise enough money and need financial help with the balance.
