An additional hour and forty-five minutes per day would be added to the instructional day to allow students to have extra high quality experiences at school within the classroom and assist teachers in assuring students are ready to be successful upon kindergarten entry.

Charter bus is suggested to reduce the amount of time the students will spend traveling due to facilities on the bus and also the large luggage compartment to transport pre-assembled items used in competition. Students compete on a Science Olympiad team that is a model program in the “National Science Standards’ by the National Research Council. Allen Elementary had students to place first in several categories in previous state competitions. To compete in the competition is an accomplishment for Floyd County School District. Due to the number of miles (484 round trip) students will be less fatigued. The restrooms on the bus will cut down on the number of stops to the competition.

An ARC may determine that the length of the school day can be changed for a child or youth if the medical condition (provided by the physician) of the child or youth indicates that the instructional needs to be altered based upon written evidence. The local education agency shall submit requests for shortened school day to the local Board of Education for approval prior to modification to the Kentucky Department of Education.
