Within this grant, \$75,000 per year for 4 years is earmarked to member districts of KVEC to fund the Technology Innovation Coordinator.

ORDER NO. 18200 Knowledgenet Agreement (Item 6-Q)

Ms. Meade made the motion and Ms. Robinson seconded the motion to approve retroactive agreement between Floyd County School System and Knowledgenet, which is a professional development training course for District IT staff.

BOE Policy 01.11 General Powers and Duties of the Board. Knowledgenet is a self-paced e-learning library that offers general knowledge training as well as preparation for multitude of industry certifications. The content in this solution is organized around vendor certification exam objectives, and correlates to classroom instruction ensuring that the necessary skills are learned in preparation for each exam. Also, the program is maintenance specific to the hardware that Floyd County uses.

ORDER NO. 18201 Teach for America (Item 6-R)

Ms. Meade made the motion and Ms. Robinson seconded the motion to approve memorandum of agreement between the Floyd County School System and Teach for America, Inc. There was an affirmative vote by all board members present to approve the motion. The motion carried.

BOE Policy 01.11 General Powers and Duties of the Board. Teach for America is an organization that has gained approval through the legislature, KDE, and EPSB. The program identifies individuals who are committed to serving as teachers in rural or urban areas and that are willing to make a two year commitment to stay in the district in which they are hired.
