KRS 162.90 Powers and Duties of the Local Board. This agreement is required to receive reimbursement by the district from the grantee for costs incurred for operation of the Floyd County Head Start Program.

Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve commercial card agreement with Fifth Third Bank.

BOE Policy 01.11 General Powers and Duties of the Board. This program, once fully implemented could produce \$25,000 plus in rebates per budget year. The 5/3rd Bank Commercial Card Program is designed to provide entities with an option to pay vendors with a commercial card, which in turn generates rebates back to the district. This program can also by used as a procurement card system enabling the district to make online purchases, book and pay for motel rooms, and other purchases requiring some form or credit card. The program is setup to have multiple safeguards and internal controls, ensuring that abuse does not take place.

Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve abolishing classified Education Coordinator position and creating certified Early Childhood Education Consultant for the Early Childhood Program.

KRS 162.90 Powers and Duties of the local board. All costs associated with the new position will be paid from Head Start funds and will be an increase of \$21,780 from last

year. This increase will be offset by reduced costs in transportation made possible by including early childhood students on regular district bus routes.

While using KISTA as a financing source is not the preferred method, the interest rates are low.

No other applicants have applied, therefore we are asking for emergency certification. The staff member has been teaching this class since the beginning of the 2012-2013 school year and the request for certification is supported by the school principal. It is anticipated the employee will complete all requirements for standard certification in November of 2012.
