Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve a resolution of the Floyd County Board of Education authorizing the Floyd County School District Finance Corporation to issue refunding revenue bonds for the 2006 Issue.

BOE Policy 01.1. Interest rates have stabilized and our fiscal agent has been monitoring one of our bond issues for the possibility of refinancing. Based on recent bond interest rates, our 2006 issue now meets the minimum requirements of KDE to refinance. The fiscal agent is projecting a savings of \$348,350 over the remaining years of the issue for an annual average savings of \$. The current rate on the bond is 4.10% and it is believed the refinance issue would be at 2.35%. Results in a projected savings of \$348,350 in bond payments, which should free up an additional \$500,000 in bonding potential.

This program provides the students the opportunity to enhance their knowledge and performance skills in the arts and allows them to showcase their artistic talents to the entire school system and community at large. General Fund will cover the cost of \$4,900 total. This will be for 3 choral conductors, 3 visual artists, 2 band conductors @ \$500 each (plus mileage), 3 piano accompanists @ \$300 each (unless accompanist is being paid as Floyd County personnel).

As a result we have seen higher participation rates from each of our schools in the breakfast and lunch program. As a result the revenue produced by these programs has also increased during this period of time. Due to the higher participation rate a labor study has been completed that follows the Kentucky Department of Education's guidelines. As a result of the study and day-to-day observation of the school nutrition program it has been determined that an additional cook position at each of the following schools is necessary: Allen Elementary, Betsy Layne Elementary, Duff/Allen Central Middle School, May Valley Elementary, and Prestonsburg Elementary School.

In order to maintain and accommodate these events it is necessary to provide school nutrition staff to work during these special activities or events. These positions would be utilized only during these types of activities or events and they would not be utilized on a daily basis. Approval for these positions would be given by the School Nutrition Director after consultation with the Superintendent on a case by case basis.

Policy 0.1.11 General Powers and Duties of the Board of Education. Many years ago, hospitals were responsible for blood supplies. The common practice for collecting blood for transfusions was to collect donations from patients' family and friends or even from the hospital staff. In some cases, family members were required to recruit donors before their loved ones could have surgery. In 1968, a group of concerned Lexington doctors decided blood should be collected, tested and distributed from a central location to give every hospital an equal chance to get needed blood without worrying if there would be enough to go around. With the help of volunteer blood donors, Kentucky Blood Center (KBC) provides blood products to nearly 70 Kentucky hospitals and clinics in more than 60 Kentucky counties.

ORDER NO. 18449 School Science Curriculum Maps (Item 6-T)

Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve funding for District-Wide elementary, middle and high school science curriculum maps and common assessments to be purchased from the National Generation Appalachian STEM Institute.

BOE Policy 01.11 General Powers and Duties of the Board. The state of Kentucky is I the process of switching from the Core Content Assessment 4.1 in the area of science to the Kentucky Core Academic Standards (KASC) in all grade levels K-12<sup>th</sup>. As we transition from the old standards to the new standards we want to ensure that our students have the opportunity to perform at a high level so we would certainly benefit from an aligned curriculum map with common assessments. A team of Floyd County master science teachers have received many sets of sample curriculum documents. We have determined that The Next Generation Appalachian STEM Institute has a strategic design team of master practicing science teachers who have worked under the guidance of a curriculum framework with common assessments. With the purchase of the curriculum framework and assessments we feel that our district would be able to continue to focus on providing our students a world class education.

ORDER NO. 18450 Individual Professional Growth Plan (Item 6-U)

Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve the addition of the Individual Professional Growth Plan (IPGP) to the Floyd County Certified Evaluation Plan.

There was an affirmative vote buy all board members present to approve the motion. The motion carried.

KRS 162.90 Powers and duties of the local board. All schools are currently participating in the newly developed PGES evaluation program. Since the plan was adopted by the Floyd County Board of Education, more recommendations, suggestions, and requirements have come from the Kentucky Department of Education thus requiring changes\additions to our approved document. One of those recommendations is the addition of our IPGP to the official certified evaluation plan.

ORDER NO. 18451 Pikeville Campus Tour (Item 6-V)

Ms. Meade made the motion and Ms. Gearheart seconded the motion to approve Betsy Layne High School's request to travel to the University of Pikeville Campus for campus tour, tour new facilities, ID cards, and lunch. Busing will be provided by the University of Pikeville.

There was an affirmative vote buy all board members present to approve the motion. The motion carried.

Board Policy 9.36, Board must approve all travel on commercial carriers. KRS 162.90 and Board Policy 02.2234. Powers and duties of the local board of education. The University liaison contacted the school and wants to transport those students enrolled in dual credit classes through

the University of Pikeville to their campus to complete their trip from September. The Opening Convocation ran long and the student campus tour was cut short. They were also unable to make student ID's for all students due to timing. The dual credit students will be completing a tour of campus, touring the new media center and having their UPIKE ID's made as well as their lunch provided. This will afford the students an opportunity to complete their visit to UPIKE college campus and help in their choices about where they would like to attend college.

ORDER NO. 18452                      School Nutrition Program Surplus Spending
