Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve an Extended School Services (ESS) Tutor position at McDowell Elementary for the 2014-15 School Year.

Policy 0.1.11 General Powers and Duties of the Board. By law, each school is required to offer ESS services for students. These services will be offered during the regular school day. Students will be selected based on one or more of the following criteria; students who are below grade level, at-risk of being retained, in need of additional reinforcement/practice on a matter skill/concept.

ORDER NO. 18374                      ESS Positions (Item 6-N)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve (2) May Valley ESS (Extended School Services) Tutor positions for the 2014-15 School Year.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

Policy 0.1.11 General Powers and Duties of the Board. By law, each school is required to offer ESS services for students. May Valley Elementary has been approved to offer a Daytime ESS program. These services will be offered during the regular school day. Selection of students will be based on one or more of the following: in danger of falling behind in key subject matter, at risk of being retained in the present grade, in need of additional reinforcement/practice on a major skill/concept.

ORDER NO. 1837 9                      Driver Trainer Position (Item 6-O)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve reduction in number of annual contract days from 240 to 220 for driver trainer position at the Department of Transportation.

KRS 162.90 Powers and duties of the local board. Reducing the number of days in this position would lessen labor expenses for the Department of Transportation by \$3000 for the first year using an employee with twenty years of experience as an example.

Board policy 1.11 general powers and duties of the board. The Accelerated Reading Program is a vital part of McDowell Elementary School’s language arts program.

KRS 162.90 Powers and duties of the local board. During the June 23<sup>rd</sup>, 2014 meeting, the Board passed order #18224 which directed that all district bus routes be four hours in duration including vocational routes if there was a change in the driver of a vocational route. It was the intent of the Board that current vocational drivers were exempted from the order as long as they drove vocational routes. The change was made subject to the longstanding driver work rules and there was no intent by the Board to exempt any or all current drivers of vocational routes from the process for assigning extra routes.

Students have enrolled and have been determined initially eligible for a total of eligible students that is well over what is allowable for a teacher’s caseload in regulation at 3 schools. In order to meet the education needs of the students and to comply with Kentucky Administrative Regulations dealing with implementation of Individual Educational Programs and Placement Decisions. I propose the following positions: .5 LBD teacher at Duff Elementary, .5 LBD teacher at Prestonsburg Elementary and 1.5 LBD teachers at Betsy Layne Elementary.

Temporary para professionals have been utilized to meet the increased needs of students who have transferred to or became eligible at the following schools: Prestonsburg High School, Betsy Layne Elementary ps/hs, JM Stumbo, and Osborne

Elementary. These positions will be needed full time for the 2014-15 school year. Salary and fringe costs will be paid with IDEA funds.

ORDER NO. 18384                      KHEAA Program Participation (Item 6-T)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve South Floyd School to participate in KHEAA program

There was an affirmative vote by all board members present to approve the motion. The motion carried.

BOE approval of grant acceptance. Participation in this program will provide SFS students strong, specific guidance in their search and completion of college readiness.

ORDER NO. 18385                      Common Carrier (Item 6-U)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve Allen Central Middle Schools request to use common carrier (Miller Brothers Transportation) to transport students during Kentucky Youth Assembly.

Policy 0.1.11 General Powers and Duties of the Board. Kentucky Youth Assembly provides students the opportunities to present a Bill to the Senate and the House of Representatives.

ORDER NO. 18386                      Travel for Betsy Layne High (Item 6-V)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to retroactive approve Betsy Layne High School to travel to the University of Pikeville Campus for Convocation Program, Tour, ID Cards and Lunch. Busing will be provided by the University of Pikeville with Board approval.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

Board Policy 9.36, KRS 162.90 and Board Policy 03.2234. Board must approve all travel on commercial carriers, Powers and duties of the local board of education. Students do not always get the opportunity to visit a college campus and tour the facility, nor do they get to participate in an opening convocation. This will provide that opportunity to BLHS students at no cost to the student or the school in these tough economic times.

ORDER NO. 18387                      Part-Time Position (Item 6-W)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to approve part-time position of Alternative

Education Program at Allen Central High School for the 2014-2015 School Year.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

KRS 162.90 Powers and duties of the local board. It is anticipated that an Alternative Education Program (AEP) would prove to be very successful at ACHS. The basic improvement goals will be in the areas of study skills, individual and group behavior standards, and student attendance. The position will be paid from Section VI funds.

ORDER NO. 18388                      Flooding at Betsy Layne High (Item 6-X)

Ms. Meade made the motion made the motion and Dr. Varia seconded the motion to receive information related to the flooding that occurred at Betsy Layne High School.

There was an affirmative vote by all board members present to approve the motion. The motion carried.

The cost for cleaning and painting football field and surroundings back to as original state is estimated at \$70,000. Thirty (30) thousand is estimated for debris cleanup, such as removing mud, cleaning ditches, and pressure washing. The cost for removing the mud from the football field turf will be approximately forty (40) thousand dollars.

The Budget Committee also recommended this allocation.
